- 3. Under this process, the Technical bid Application as well as Price Bid shall be invited at single stage under two Envelope i.e. Technical & Commercial Envelope. Eligibility and qualification of the Bidderwill be first examined based on the details submitted under first envelop (Technical) with respect to eligibility and qualification criteria prescribed in this Biddingdocument. The Price Bid under the second envelope shall be opened for only those bidders whose Technical Applications are responsive to eligibility and qualifications requirements as per biddingdocument.
- 4. All bidders are required to sign a "Bid Security Declaration" accepting that if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the tender document, they will be suspended for the period of two years. This suspension of two years shall automatic without conducting any enquiry.
